GUIDANCE NOTES

Members of the public are required by law to declare interests when they become a Councillor or non-elected Member. 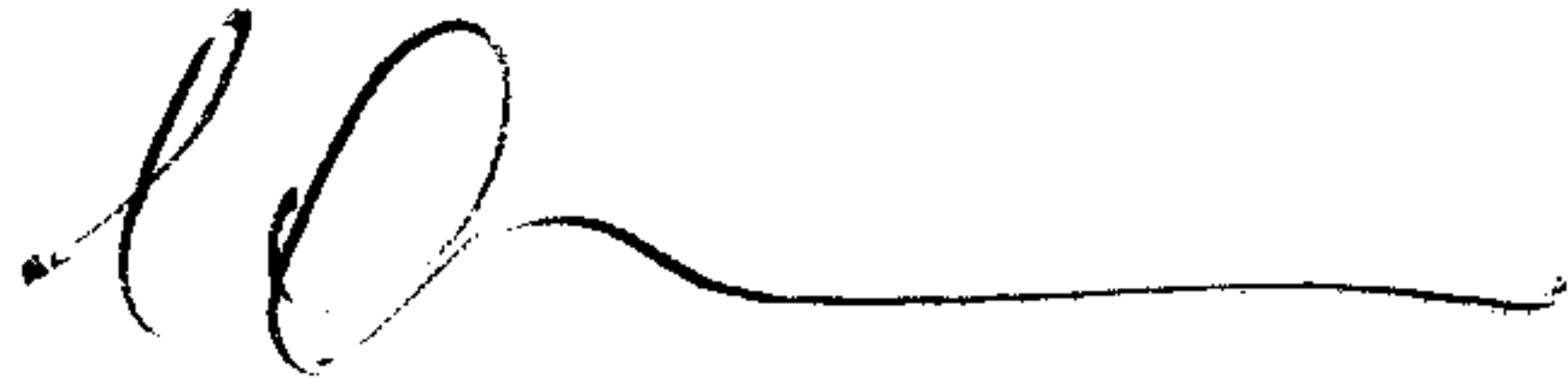
